1. Introduction and Context

On 4 November 2020, published a combined conclusions and consultation document¹. The combined document set out DCC's conclusions that a collection of MOC (Secure) related changes to the SMETS1 Supporting Requirements (S1SR) (which includes the Device Model Variations to Equivalent Steps 'DMVES' as Annex E) were fit for purpose. The combined document also proposed a date for re-designation of the S1SR and sought view on this date.

This document provides a conclusion report for the consultation on the date for re-designating the S1SR.

2. Stakeholder Engagement

On 4 November 2020, DCC published the consultation document titled '[SMETS1 Conclusions on the S1SR for MOC \(Secure\) and Date Consultation](#)' on the DCC Website and DCC's Service Desk also emailed stakeholders to notify them of its publication. Stakeholders were invited to respond by 16:00 on Wednesday 11 November 2020 via a template titled '[SMETS1 Conclusions on the S1SR for MOC \(Secure\) and Date Consultation – Response Template](#)'.

3. Analysis of Responses

The consultation asked a single question "***Do you agree with the proposed re-designation date of 16 November 2020 (or, if necessary, as soon as reasonably practicable within one month thereafter) for the updates to the S1SR using draft notification at Attachment 1?***".

DCC received four written responses to this consultation which were provided to the Secretary of State once the consultation had closed. All written respondents expressed support for the proposal without further comment.

4. Conclusion

DCC is of the opinion that it has had appropriate consultation with industry regarding the re-designation date for the S1SR. DCC considers that further consultation is neither necessary nor appropriate. DCC concludes that the proposal for the Secretary of State to re-designate these SEC Appendices on Tuesday 16 November 2020 (or, if necessary, as soon as reasonably practicable within one month thereafter) using the text set out in Attachment 1 to the combined document² is acceptable to industry.

5. Next Steps

On 13 November 2020, DCC submitted this conclusion report to the Secretary of State and published it on DCC's website. DCC's submission to the Secretary of State also included DCC's prior conclusion report³ that recommended the revised S1SR as fit for purpose.
