## 1. Introduction and Context

On 29 January 2021, DCC published a combined conclusions and consultation document<sup>1</sup>. The combined document set out DCC's conclusions that a collection of FOC related changes to the SMETS1 Transition and Migration Approach Document (TMAD) were fit for purpose. The combined document also proposed a date for re-designation of the TMAD and sought view on this date. This document provides a conclusion report for the consultation on the date for re-designating the TMAD.

## 2. Stakeholder Engagement

On 29 January 2021, DCC published the consultation document titled 'SMETS1 Conclusions on TMAD Changes and consultation on redesignation date on the DCC Website and DCC's Service Desk also emailed stakeholders to notify them of its publication. Stakeholders were invited to respond by 16:00 on Thursday, 4 February 2021.

## 3. Analysis of Responses

The consultation asked a single question "Do you agree with the proposed re-designation date of 28 February 2021 (or, if necessary, as soon as reasonably practicable within one month thereafter) for the updates to the TMAD using draft notification at Attachment 1?". DCC received no written responses to this consultation.

Following the closure of the consultation, DCC contacted a number of impacted stakeholders given the limited initial response. One respondent advised DCC that they had no concern with the redesignation date and no further comment. Another respondent indicated that they were supportive of the date and had no specific comments.

## 4. Conclusion

DCC is of the opinion that it has had appropriate consultation with industry regarding the redesignation date for the TMAD. DCC considers that further consultation is neither necessary nor appropriate. DCC concludes that the proposal for the Secretary of State to re-designate these SEC Appendices on 28 February 2021 (or, if necessary, as soon as reasonably practicable within one month thereafter) using the text set out in Attachment 1 to the combined document<sup>2</sup> is acceptable to industry.

## 5. Next Steps

On 25 February 2021, DCC submitted this conclusion report to the Secretary of State and published it on DCC's website. DCC's submission to the Secretary of State also included DCC's prior conclusion report that recommended the revised TMAD as fit for purpose.
