1. Introduction and Context

On 27 July 2021 DCC issued a consultation proposing changes to the S1SR to support Uplift 2.2 for FOC¹. This consultation closed on 20 August 2021. On 14 September 2021, DCC published the conclusions to that consultation and a further consultation on the S1SR to support Uplift 2.2.² This consultation closed on 28 September 2021 and DCC published its conclusions to this consultation on 05 October 2021.³

The implementation of these changes was delayed and DCC has consulted on a new date for the Department for Business, Energy and Industrial Strategy (BEIS) to redesignate these changes to the S1SR.

On 19 October 2021, DCC issued a consultation on behalf of BEIS. This consultation sought views on the date for the redesignation of the SMETS1 Supporting Requirements (S1SR) (which includes the Device Model Variations to Equivalent Steps 'DMVES').

This document provides a conclusion report for the 19 October 2021 consultation.

2. Stakeholder Engagement

On 19 October 2021 DCC published a consultation document titled: "*DCC consultation on designation of the SMETS1 Supporting Requirement in support of Uplift 2.2*" on the DCC website and DCC's Service Desk also emailed stakeholders to notify them of its publication. Stakeholders were invited to respond by 16:00 on 26 October 2021.

3. Analysis of Responses

DCC asked the following question in the consultation: "Do you have any comments on the draft direction included in Attachment 1 or on the proposed date of 3 November 2021 (or as soon as reasonably practicable within 1 month thereafter) for redesignation of the S1SR?".

DCC received two written response to this consultation, which were provided to the Secretary of State once the consultation had closed. One respondent confirmed that they supported the proposed date. One respondent indicated that they have no objection to the proposed date.

4. Conclusion

DCC is of the opinion that it has had appropriate consultation with industry regarding the redesignation date for the S1SR. DCC considers that further consultation is neither necessary nor appropriate. DCC concludes that the proposal for the Secretary of State to redesignate the S1SR on Tuesday 3 November 2021 (or, if necessary, as soon as reasonably practicable within one month thereafter) using the text set out in Attachment 1 to the consultation document is acceptable to industry.
