1. Introduction and Context

A number of energy suppliers have installed first generation smart devices (known as SMETS1 devices) in consumers' premises across Great Britain. The Data Communications Company (DCC) has designed a solution for the enrolment of SMETS1 devices into its network. Part of DCC's plan to deliver SMETS1 services involves a detailed approach for migrating SMETS1 Installations into DCC's systems.

The detailed technical and procedural requirements of the migration approach are set out in the SMETS1 Transition and Migration Approach Document (TMAD). The TMAD is Appendix AL of the Smart Energy Code¹ (SEC).

The latest version of the SEC was published on 4 November 2021 as v50.0

This request for information has been published by DCC to all Responsible Suppliers in order to gather data where it has been identified that a responsible supplier believes SMETS1 dormant devices are present in their portfolio, but these devices are not included in the data provided by DCC to Suppliers on a monthly basis.

2. Background

An initial assessment on a small proportion of the dormant SMETS1 estate held by DCC was undertaken at the request of Responsible Suppliers and MAPs who identified devices that were never on the SMETS1 SMSO or no longer on the SMETS1 SMSO.

Analysis of the assessment highlighted that dormant devices were not available for DCC to migrate. Alongside DCC's obligations to maximise dormant migration DCC is supporting BEIS to obtain data on dormant devices that are unaccounted for in order to impact assess the potential scale and breadth of the dormant devices that do not appear on the data provided by the SMETS1 SMSOs across all cohorts.

3. Request for Information

DCC is requesting that each Responsible Supplier reconciles the dormant data (file format *"Port_SECID_export_YYYMMDD_HHMMSS"*) provided monthly by the DCC into the Responsible Suppliers SharePoint folder **SMETS1 Migration -> Notification -> Inbox**, against the Responsible Supplier's dormant portfolio. This will identify compliant SMETS1 dormant devices that the Responsible Supplier believes should be considered for a migration attempt but is not held within the data provided by the DCC.

Please complete the attached template and place in the **SMETS1 Migration** -> **Miscellaneous** -> **Outbox** SharePoint folder. Once received, DCC will review and then collate all responses. These responses will also be provided to BEIS for their consideration.

4. Next Steps

DCC will collate and analyse the scope and status of the devices provided with the relevant SMSO in order to report this to BEIS alongside advice on whether DCC consider there are technically viable and economically efficient means of migrating identified sites, taking action to do so where that falls within DCC existing remit.

Where determined that an installation or device is not feasible for migration DCC will notify the Responsible Supplier. This will not be an ongoing activity.

This template should be submitted in Excel (XLSX) format and should have the file header "RFI_SECPARTYID_YYYMMDD.xlsx" renamed to have the Respondent's one SEC Party ID and submission date.

Given the nature of the RFI, all data provided will be treated as confidential by DCC.
